NOTICE TO BIDDERS

SEALED BIDS will be received by the Village Clerk of the Village of Asharoken ("Village") in the Village Hall located at One Asharoken Avenue, Northport, NY 11768 on **Monday, September 30th, 2019 at 2:00pm.**, at which time they will be publicly opened and read and the Contract awarded as soon thereafter as practicable for:

MUNICIPAL SOLID WASTE, YARD WASTE, BULK WASTE & DUAL-STREAM RECYCABLE COLLECTION

Bid packages may be obtained at the Village of Asharoken, One Asharoken Avenue, Northport, NY 11768 between the hours of 9 a.m. to 3 p.m. Monday-Thursday 8 a.m. to 2 p.m. Friday.

Bids may be mailed or delivered to the Village Clerk, Village of Asharoken, One Asharoken Avenue, Northport, NY 11768, provided the Bid is actually received by the Village Clerk prior to the time of public opening; or Bids may be delivered to the place of public opening immediately prior to the time of public opening. All Bids must be sealed and submitted in the envelope provided with the Bid package.

FAXED OR ELECTRONIC BIDS WILL NOT BE ACCEPTED, DELIVERY BY SUCH METHODS SHALL RESULT IN AUTOMATIC DISQUALIFICATION.

Each bid must be submitted on the official forms furnished by the Village. Each bid must be accompanied by a certified check or bond in a sum equal to five percent (5%) of the bid amount for the full bid year (6/1/2020-5/31/2021), payable to the Village of Asharoken. The failure or refusal to execute the Contract and deliver the required bonds and insurance certificates within (30) thirty days after the date of notice of acceptance of the bid shall constitute a breach of the agreement and the Village of Asharoken may proceed against the bid bond or take such action as may be deemed in the Village's best interest.

ALL BIDDERS MUST complete the required Qualification Statement and must provide a copy of a current financial statement, even if a Bidder is currently executing work for the Village.

ALL BIDDERS MUST execute a non-collusive bidding certification required by Section 103-d of the General Municipal Law of the State of New York.

ALL BIDDERS MUST complete the Iranian Energy Sector Divestment certification required by Section 103-g of the General Municipal Law of the State of New York.

ALL BIDDERS MUST comply with the anti-discrimination provisions of Section 290-301 of the Executive Law of the State of New York.

The Bids shall be in accordance with the terms of the proposed Contract.

No bids shall be received unless made in writing on forms furnished, and unless accompanied by a Certified Check or Bid Bond made payable to the Village of Asharoken for an amount not less than five (5%) percent of the bid price.

BIDDERS ARE HEREBY ADVISED THAT ALL BONDS AND INSURANCE DOCUMENTS SUBMITTED WILL BE VERIFIED FOR AUTHENTICITY BY DIRECT COMMUNICATION WITH THE SURETY/INSURANCE COMPANY.

ALL BONDING AND INSURANCE COMPANIES MUST BE LICENSED TO DO BUSINESS IN THE STATE OF NEW YORK.

The Village reserves the right to reject any and all Bids, and to waive any informalities therein.

The Village will not accept Bids from, nor award a Contract to, anyone who cannot prove to the satisfaction of the Board of Trustees that the Bidder has sufficient experience in this type of service and financially able and organized to successfully carry out the terms of the Contract. Special qualification requirements are contained in the Contract Documents.
